AGE, IMPORTANT NOTE AND REMAINING **QUALIFICATION PRE-CONDITIONS** 

> 21 to 30 years on 1st January 2020. In case of officials AGE: serving in connection with the affairs of the Federal Government who are domiciled in the Punjab as well as the officials serving in connection with the affairs of the Punjab Government having at least 4 years service as such, the upper age limit shall be 35 years. For special persons, maximum 10 years relaxation in upper age limit shall be allowed as per Punjab Civil Servants Recruitment (Relaxation of Upper Age Limit) Rules, 1976.
