## **ELIGIBILITY CRITERIA FOR SCRUTINY**

SUBJECT:

RECRUITMENT TO (01) ONE POST OF ADDITIONAL DIRECTOR (L&PA) ON OPEN MERIT ON CONRACT BASIS FOR THE PERIOD OF TWO YEARS IN THE LAW & PARLIAMENTARY AFFAIRS DEPARTMENT.

## QUALIFICATION:

- (i) (LL.M., OR Bar-at-law, or LL.B (50% marks in the aggregate), or equivalent qualification from a reputed University/Institution recognized by the Higher Education Commission; and
- (ii) In case of LL.B., and Bar-at-law, ten years; and, in case of LL.M., eight years (i) active practice as advocate High Court; or (ii) experience as judicial officer; or (iii) experience in drafting of substantive and delegated legislation and other legal instruments in public or private sector of repute; or (iv) the aggregate of experiences at (i), (ii) and (iii); or (v) five years' experience of drafting/vetting of substantive and delegated legislation and legal instruments as Deputy Director (Legislation and Parliamentary Affairs) in the Law and Parliamentary Affairs Department.

### NOTE:

Preference shall be given to a person who: (a) also possesses the recognized qualification of legislative drafting; or who has at least three years practical experience of drafting/ vetting of substantive and delegated legislation and legal instruments of legislative drafting; and (b) has satisfactory knowledge of Microsoft office and other related computer applications.

AGE LIMIT:

Male Candidates: 32 to 50 + 05 = 55 Years. Female Candidates: 32 to 50 + 08 = 58 Years.

CLOSING DATE

01 - 03-2024

The following original documents are required for eligibility to the post of ADDITIONAL DIRECTOR (L&PA) on contract basis for the period of two years.

- 1. Valid CNIC
- 2. Certificate of Matriculation/O. Level
- 3. Certificate of Intermediate/A. Level
- LL.M., OR Bar-at-law, or LL.B (50% marks in the aggregate) Transcript/ DMC showing total marks & Obtained marks/ percentage of marks issued by the Controller of Examination of College/University.
- 5. 10 years or 08 years' Experience Certificate as described above.
- Domicile certificate issued on or before the closing date or in case Domicile Certificate is issued after the closing date documentary evidence for submission of application for domicile, before closing date to the issuing Authority.
- Departmental Permission Certificate issued by the Appointing Authority in case of Government employees.
