Subject:- **RECRUITMENT TO (03) THREE POSTS OF PRINCIPAL (BS-18) ON CONTRACT BASIS FOR A PERIOD OF FIVE YEARS IN THE (PUNJAB WORKERS WELFARE BOARD) PUNJAB LABOUR & HUMAN RESOURCE DEPARTMENT.**

Qualification / Experience:

- a) Master Degree (second division) in Arts or Science from a recognized University or equivalent qualification or M.Ed (second division) from a recognized University or equivalent qualification; and
- b) At least seven year's teaching cum administrative experience in an institute recognized by the Government before or after acquiring the prescribed qualification.

AGE LIMIT:

Male: 30 to 45 + 07= 52

Female: 30 to 45 +10= 55 Years on **19-09-2022.**

6. Original Degree M.Ed (2nd division) /DMC showing Obtained & Total Marks/percentage of marks issued by the Controller of Examination.
7. Original Domicile certificate or documentary proof issued on or before the closing date i.e. **19-09-2022** for submission of application for issuance of domicile certificate before the closing date by the issuing Authority/District Coordination Officer/Deputy Commissioner of any District of Province of Punjab.
8. Departmental Permission Certificate on prescribed Performa of PPSC-5 duly issued by the Appointing Authority in case of Government employees/Semi or Autonomous bodies.
9. Equivalence Certificate of qualification from concerned Administrative Department/QEDC of Administrative Department as the case may be.
10. Disability Certificate duly issued/verified by Social Welfare Department Government of Punjab **(if required)**.
