**GUIDANCE ON ELIGIBILITY / SCRUTINY CRITERIA**

SUBJECT:- **RECRUITMENT TO 05 POSTS (INCLUDING 01 POST RESERVED FOR WOMEN QUOTA) OF INSPECTOR OF BOILERS (BS-16) ON CONTRACT BASIS FOR A PERIOD OF THREE YEARS IN THE PUNJAB DIRECTORATE GENERAL OF INDUSTRIES, PRICES, WEIGHTS & MEASURES, PUNJAB, LAHORE.**

**Qualification / Experience:**

- i) Three years diploma in Mechanical Engineering, from a recognized Board.
- ii) First Class Boilers Engineers Competency Certificate under the Boilers and Pressure Vessels ordinance, 2002 (CXXI of 2002); and
- iii) Three Years practical experience in repair and maintenance of steam boilers.

**Note:-**

- i) Experience in private entities shall be accepted if such entity is registered with SECP, Registrar of Firms or any other Regulatory Authority.
- ii) The Requisite Experience must be after acquiring the prescribed qualification.

**AGE LIMIT:** **Male:** 21 to 28 + 7 =35 years **Female:** 21 to 28 + 10 =38 years

General relaxation in upper age limit vide Notification No. SOR-I (S&GAD) 9-36/81 dated 21-05-2012 and Notification No.SOR-I (S&GAD)9-2/2022 dated 26-01-2022.

**CLOSING DATE:**

Following documents other than the possessed qualification as mentioned above, must be obtained from each candidate for scrutiny purpose at the time of interview:-

1. Original Valid CNIC (It must not be expired on last day of applying online for the subject post).
2. Original Certificate of Matriculation / O level showing Obtained & Total Marks.
3. Original Three years diploma in Mechanical Engineering showing Obtained & Total Marks. Or Percentage Certificate issued by competent Authority.
4. First Class Boilers Engineers Competency Certificate under the Boilers and Pressure Vessels ordinance, 2002 (CXXI of 2002); and
5. Three Years practical experience in repair and maintenance of steam boilers after prescribed Qualification.
6. Original Domicile Certificate issued on or before the closing date i.e. **10-10-2022**
7. Departmental Permission Certificate on prescribed Performa of PPSC-5 duly issued by Appointing Authority in case of Government/Semi-Government employees/Autonomous bodies.
8. Experience in Private entities shall be accepted if such entity is registered with SECP, Registrar of Firms or any other Regulatory Authority. **(Candidate must provide firm/company registration proof for the period he/she worked in the concerned organization)**
